

SPRING 2008 “Trip A Day” contest rules

“TRIP A DAY” RULES

- 1. HOW TO ENTER THE CONTEST:**
 - a. THE “TRIP A DAY” CONTEST WILL BEGIN ON April 7, 2008 and end on June 13, 2008. Excluding Monday, May 26, 2008.**
 - b. TO PARTICIPATE IN THE CONTEST, JOIN THE SMOOTH JAZZ LISTENER CLUB NOW BY FAXING, MAILING OR E-MAILING YOUR NAME AND WHERE YOU WORK TO WSJT. MAIL TO WSJT AT 9721 EXECUTIVE CENTER DRIVE, SUITE 200, ST. PETERSBURG, FL 33702, FAX NUMBER (727) 568-WSJT (9758, OR GO TO WEBSITE AT WWW.WSJT.COM TO ENTER – MUST BE A MEMBER OF THE SMOOTH JAZZ LISTENER CLUB by May 26, 2008.**
 - c. ONCE YOU HAVE JOINED THE SMOOTH LISTENER CLUB, YOU WILL BE AUTOMATICALLY ENTERED TO WIN THE “TRIP A DAY” CONTEST AND ALL FUTURE WORKDAY CONTESTS ON WSJT.**

- 2. ELIGIBILITY RESTRICTIONS**
 - a. THE CONTEST IS OPEN TO ALL WSJT 94.1 LISTENERS WHO ARE 18 YEARS OF AGE OR OLDER, RESIDE IN THE WSJT 94.1 LISTENING AREA. EMPLOYEES OF WSJT 94.1, ITS CORPORATE PARENT CBS RADIO, AFFILIATED ENTITIES, ITS AFFILIATED ADVERTISING AGENCIES, PARTICIPATING SPONSORS/PROMOTIONAL PARTNERS, OTHER RADIO STATIONS IN THE TAMPA METROPOLITAN AREA AND MEMBERS OF THEIR IMMEDIATE FAMILIES ARE INELIGIBLE TO PARTICIPATE OR WIN.**
 - b. LISTENERS ARE ELIGIBLE TO WIN A WSJT CONTEST ONLY ONCE EVERY THIRTY DAYS. ONLY ONE WINNER PER HOUSEHOLD IS PERMITTED IN ANY CONTEST.**
 - c. LISTENERS ARE ELIGIBLE TO WIN A PRIZE VALUED AT \$600 OR MORE ONLY ONCE EVERY SIX MONTHS.**

- 3. PRIZES**
 - a. ROUND TRIP TICKETS FROM TAMPA FOR TWO ANYWHERE IN THE CONTINENTAL UNITED STATES. PRIZE DOES NOT INCLUDE ACCOMMODATIONS OR FOOD/BEVERAGES. APPROXIMATE PRIZE VALUE - \$300 PER TICKET. A TOTAL OF 48 PAIRS OF TICKETS WILL BE AWARDED.**
 - b. TRIPS WILL BE GIVEN AWAY ONCE A DAY MONDAY THROUGH FRIDAY, BETWEEN 9 A.M – 5 P.M. STARTING ON April 7, 2008 and ending on June 13, 2008. Excluding Monday, May 26, 2008. THE WINNER MUST SIGN AND RETURN RELEASE FORM WITHIN SIXTY DAYS OF WINNING. WSJT 94.1 IS NOT RESPONSIBLE FOR THE SAFE ARRIVAL OF A PRIZE OR PRIZE CERTIFICATE AND PRIZES LOST, DELAYED OR DAMAGED WILL NOT BE REPLACED BY WSJT 94.1.**

- c. **CONTEST PRIZES ARE NOT TRANSFERABLE. PRIZES MAY NOT BE SUBSTITUTED FOR OR REDEEMED FOR CASH, RESTRICTIONS/BLACK OUT-PERIODS MAY APPLY.**
- 4. SELECTION OF WINNERS:**
- a. **DECISIONS OF STATION MANAGEMENT WITH RESPECT TO THE CONTEST ARE FINAL.**
 - b. **WINNERS WILL BE CHOSEN MONDAY THROUGH FRIDAY FROM THE "LISTENER CLUB" DATABASE April 7, 2008 through June 13, 2008. Excluding Monday, May 26, 2008.**
 - c. **A RANDOM NAME FROM OUR SMOOTH JAZZ LISTENER CLUB WILL BE ANNOUNCED ON-AIR, THAT PERSON WILL HAVE 60 MINTUES TO CALL BACK TO WIN THE TRIP. IF THAT PERSON DOES NOT CALL BACK, WITHIN THE REQUIRED TIME PERIOD, ANOTHER NAME WILL BE CALLED UNTIL WE GET A WINNER. WSJT 94.1 WILL ANNOUNCE EXACTLY WHEN TO LISTEN EACH DAY.**
 - d. **IF NO ONE CALLS BACK BETWEEN 9AM AND 5PM, THAT TRIP WILL BE ROLLED OVER TO THE NEXT DAY.**
 - e. **LIMIT ONE HOUSEHOLD WINNER PER YEAR.**
- 5. CONDITIONS**
- a. **PAYMENT OF ALL FEDERAL, STATE AND LOCAL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNER. WINNERS MAY BE REQUIRED TO SIGN AN IRS FORM 1099 OR THE EQUIVALENT.**
